

Ultrafix SB4 Plus

2-Part Frame Adhesive

Applications

SAATI Ultrafix SB4 Plus Red is used for bonding mesh onto stretch & glue screen printing frames.

Characteristics

- Two-component polyurethane adhesive
- Red color with medium viscosity for use with coarse to medium mesh counts
- Adheres screen mesh to onto aluminum, steel, iron, plastic-coated, and wood frames
- Recommended to be thinned with ethyl acetate for use with higher mesh counts

Features/Benefits

- Fast drying and curing time for maximum initial adhesion – allows screens to be removed quickly from stretching system and saves time in stretching
- Maximum flexibility & adhesion prevents premature failure and enables maximum screen life
- Excellent resistance to heat & solvents for repeated use in automated screen reclaiming systems

Directions For Use

Mix 5 parts of Ultrafix SB4 Plus adhesive with 1 part of Catalyst by weight. Use within 30 to 50 minutes. To obtain optimal adhesion, degrease the frame. Stretch the fabric over the frame providing good contact between the two. Apply the prepared mixture with a brush. After the adhesive has dried and cured, release tension and remove the screen from the stretching system. To achieve maximum heat and solvent resistance, allow adhesive to cure for 24 hours before use.

Storage

When sealed in the original container and stored in cool conditions, SAATI chemical products will maintain their original properties for two years from the date of production. Prevent from freezing.

Ultrafix SB4 Plus is available in one US gallon containers, and Catalyst is available in 22-ounce containers.
