Powder concentrate.

Remove ER2

1 to 30 liquid concentrate with built-in degreaser.

Remove ER4

Ready-to-use gel.

Remove ER5

Ready-to-use liquid with built-in degreaser.

Remove ER6

To be mixed with Remove IR 18 for “all in one” cleaning/decoating process

Remove ER10

1 to 100 liquid concentrate.

Remove ER13

1 to 60 liquid concentrate.

Remove ER25

1 to 25 liquid concentrate.

Remove ERA 1

Concentration 1:25/30.

Remove ERA 2

Concentration 1:20

DIRECTIONS FOR USE

Remove ER1

Dissolve Remove ER1 in water. Add 1 part in one hundred parts of water. Up to 2 parts per hundred of water may be used for more resistant stencils.

Remove ER2

By volume, dissolve one part Remove ER2 in 30 parts water

Remove ER4

Ready-to-use gel.

Remove ER5

Ready-to-use liquid.

Remove ER6

Mix it with Remove IR 18 as follow:

Remove IR18	2 – 3 parts
Remove ER6	1 part

Remove ER10

By volume, dissolve one part Remove ER10 in 100 parts water.

Remove ER13

By volume, dissolve one part Remove ER13 in 60 parts water.

Remove ER25

By volume, dissolve one part Remove ER25 in 25 parts water.

Apply any Remove product liberally to both sides of a wet, ink-free screen using a brush, or sponge. Let stand for 1 to 3 minutes. To speed-up removal, rub with a nylon brush. Do not allow solution to dry on screen. Use a pressure washer to remove all traces of the stencil.

Remove ERA 1

To be used in one step cleaning/reclaiming process in combination with Remove IRA 1 in a ratio 1:10:10 of water. Suitable for manual cleaning.

Remove ERA 2

To be used in one step cleaning/reclaiming process in combination with Remove IRA 1 in a ratio 1:10:10 of water. Suitable for automatic cleaning.

STORAGE

When sealed in the original container and stored at temperature between 20 and 25°C, REMOVER ER will maintain original properties for 24 months from the date of manufacture.

In North America available in one quart and in 1, 5 and 50 US gallon containers.

Remove ER10

Available in 0.05, 1, 5 and 10 kilogram containers.
In North America available in one quart and 5 US gallon containers.

Remove ER13

Available in 1, 5 and 10 kilogram containers.

Remove ER25

Available in 1, 5 and 10 kilogram containers.

Remove ERA 1

Available in 1, 5 and 25 kilogram containers.

Remove ERA 2

Available in 1, 5 and 25 Lt. containers.
